## I. Member comment, Jason

Chris Mertl, JAHA member, communicated concerns regarding the loss of out of town player five-game registration option and JAHA's direction for promoting hockey in Southeast Alaska. Board discussion generally included the opportunities that currently exist for out of town players outside of JAHA, the processes that currently exist within JAHA by-laws (late registration and the refund policies), and that administering and individual's financial and team registrations and game records outside of existing processes is not cost-effective. Jason will discuss with Christ at a later date the Board's concerns, ways JAHA is currently promoting hockey in Southeast Alaska, and any other of Chris's concerns with Chris at a later date.

II. Financial report, Christy: After the Fall season JAHA broke even. She recommended increasing the registration fee for the Winter season so that the fee per game is the same as the Fall season and so that the cost of any increase in ice rental and referee rates is covered.

No other committee reports; however, there was discussion among Board members regarding fundraising options and expenses.
