### I. Storage Space, Rick

Treadwell Arena is requiring JAHA to have jersey tubs and other miscellaneous items out of the rink by 4/16/14. Rather than pay for storage, Rick and Christy volunteered to take home the jersey tubs.

### II. Women's Playoff Game, Jason

On Monday, 3/31, a women's playoff game, Treadwell (V) vs. Huskies (H), took place. The game was tied 1-1 at the end of regulation and OT then went to a shootout. Treadwell took the first shot. After 3 rounds, the game remained tied. The shootout went into "sudden death" and Treadwell scored on their 4th round shot. The referee declared the game over and Treadwell the winner, saying that "sudden death" means first goal ends the game even in a shootout. Players from both teams felt that the Huskies, as the

home team, should have a final shot. Jason contacted Juneau Hockey Officials (JHO), emailed JAHA Board members who were not directly involved, sought input on how to proceed, and provided two viable options:

- 1) Allow the game to stand and issue a letter of apology to the Huskies.
- 2) Continue the shootout from round 4.5 before tonight's 8:15pm game, which will determine who plays in the 9:30pm game. Currently the Huskies are scheduled to play at 9:30pm, but if Treadwell were to lose the shootout continuation, they would play at 9:30pm instead.

**Motion:** Motion for the President draft a letter of apology to the losing team on behalf of JAHA and JHO made by Jess, second by Christy. Motion passed with unanimous vote, 3 abstaining (Angel, Laine, Caroline).

JHO has taken steps to inform their referees of the rules and we will clarifying the rules.

### III. Bylaws, Jason

Our bylaws more universal through working with an attorney. There was concern that the general membership could fill a Board position with someone who does not have the basic qualifications for that particular position. Jason suggested two possible solutions:

- 1) Set qualifications for officer positions
- 2) Keep elections within the Board

**Motion:** Motion by Laine for each current Executive Board member to send a list to the President for approval by Friday 4/11/2014 to generate qualifications for the four Executive Positions. Second by Christy, Caroline. Motion passed with unanimous approval.

We have donations from local businesses, giving away a helicopter ride, movie tickets, etc. Pucks were purchased that will be designed by Aurora Project for "Best of" winners.
